OpenText Core Business Communication Archive is a proven solution that indexes and stores outbound, inbound, and internal email communication. In addition to email, OpenText Core Business Communication Archive captures

and reformats data from social media platforms like LinkedIn and X (Twitter), collaboration tools like Slack and Microsoft Teams and audio and video platforms like YouTube and Vimeo. It reformats the data into electronic mail (EML) format. This data is then journaled into a searchable database with advanced search and retrieval capability, customizable retention policies and effective eDiscovery, legal hold, and data classification functionality.



Additionally, the data is stored in an immutable state on write once, read many (WORM) compatible hardware to achieve the highest levels of compliance storage requirements.

After the data has been indexed and stored, it can be searched and shared seamlessly with internal and external stakeholders. For example, HR, legal, third-party auditors, and third-party counsel by using our SimplyShare technology. Data can also be placed on legal hold to accommodate the data retention rules associated with the Federal Rules of Civil Procedure.
